AGREEMENT FOR THE RENTAL OF FACILITIES
(INCLUDING RELEASE OF LIABILITY)

I _____ agree to rent the facilities at the Napanee & District Curling Club on _____, 20____ between the hours of _____ and _____ for the purpose of staging a _____.

- Rental for Ice and Lounge – Daily \$400.00, Half a day (or part thereof) \$250.00
- Rental for Lounge/Kitchen - Daily \$150.00, Half a day (or part thereof) \$100.00
- Rental for Lounge only- \$75.00, Half a day (or part there of) \$50

NOTE:

- **YOU MUST HAVE TRAINING PRIOR TO USING THE GAS STOVE.**
- **YOU MUST HAVE TRAINING PRIOR TO USING THE DISHWASHER.**
- **IF YOU USE A CATERER THEY MUST PROVIDE AND REMOVE ALL DISHES,CUTLERY, POTS & PANS,ETC (dishwasher not available for caterers) (Club equipment is available upon request (please discuss with our Rental Representative.)**

Monday to Friday Rentals must cease before 5 pm to allow our regular curling to commence. A deposit of \$50.00/\$25.00 for ice & lounge or \$25.00/\$15.00 of lounge/kitchen will be paid at the time of signing this agreement. In the event of a cancellation, 14 days notice must be given prior to the date of the function or your deposit will be forfeited.

The representative renting the ice shall be responsible for all damages caused to the building, grounds, chattels and equipment belonging to the CURLING CLUB, reasonable wear and tear considered. The said damages are to be repaired or paid for to the full satisfaction of the management of the CURLING CLUB. **The club must be left in the clean manner that you found it.**

RELEASE OF LIABILITY:

The CURLING CLUB carries liability and accident insurance for the protection of members. The representative (group name): _____ renting the ice shall be responsible for such insurance as may be necessary for its personnel and shall assume full liability for any accident occurring in connection with the rental of ice.
